Land O Lakes' Purina Feeds LLC

Today's livestock industry is a competitive one. In order that producers succeed today — and maintain a profitable enterprise tomorrow — livestock operations require a wide range of feed products to match their herd's requirements, plus supporting services to add vitality to their livestock operations.

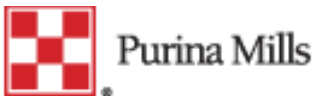
Land O Lakes' Feed LLC, located Gothenburg, NE, is one of only three corporate mills in Nebraska, helping livestock producers reach their goals.

Headquartered out of Shoreview, Minnesota, the original facility in Gothenburg was built in 1973, with the liquid feed manufacturing facility added in 1992. Land O Lakes' in Gothenburg services Land O Lakes' coops and Purina dealers in Nebraska, Kansas, Colorado, Wyoming, and South Dakota.



Land O Lakes' focuses on the manufacturing of production beef supplements such as meals, pellets, cubes, and liquids at the Gothenburg facility. These products are used primarily for cow/calf operations and in feedlots (starting and finishing).

Both Purina and Land O Lakes' branded products are produced in Gothenburg, as well as custom products for specific feedlot and cow/calf operations. The products manufactured are made to optimize the beef animals' health and growth based on the beef producers needs. Bulk ingredients, trace minerals, vitamins, etc. are pulled into the mixing process based on the supplement recipe. This mixture is then sent to the pelleting or cubing mills if required. This processed supplement is then cooled prior to loading on transports for delivery.



The facility in Gothenburg employs a total of 13 people who see as many as 20 trucks in and out each day. Land O Lakes' in Gothenburg is managed by Brian Partridge. **If you have any questions, contact Land O Lakes' Purina Feeds LLC at 308-537-2058 or stop in at 315 4th Street in Gothenburg.**

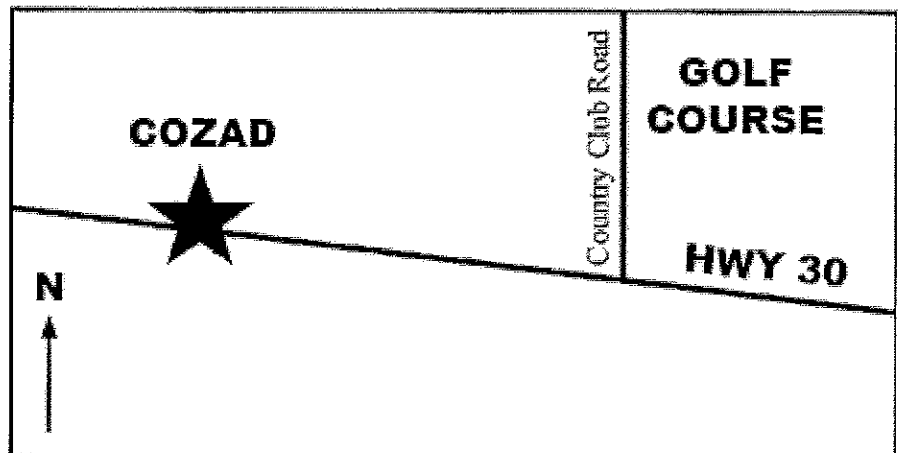


